

## Pegswood Primary School Pupil Premium Information 2020-21



Pupil premium is additional to main school funding and is allocated to schools for children who have been registered for free school meals at any time in the last 6 years, who have been looked after continuously for more than 6 months or whose parents are currently serving in the armed forces. After April 2014 in addition, it will be allocated for children who have been looked after for one day or more, are adopted or leave care under a Special Guardianship or Residence Order. The aim of the funding is to help address the current inequalities which exist between these children and their peers by raising achievement and improving outcomes.

Since September 2012 we have been required to publish online information about how we have used the funding and the impact it has had on the attainment of our disadvantaged children.

### Planned Pupil Premium Expenditure for in 2020-21

The total amount we will receive in respect of our disadvantaged pupils (FSM, ever6, CLA and forces pupils) in 2020 – 2021 will be **£73 250 (60 children)**.

We will target the attainment and progress of this group in the following ways and spend our allocation as described. Some of the interventions are pastoral, some academic and some are intended to have an impact on aspirations and experiences.

#### Barriers to future attainment for pupils eligible for Pupil Premium funding:

- An increasing number of pupil premium children also have additional needs e.g. academic, social, emotional.
- Some children are not able to complete homework tasks e.g. set homework, spelling, reading and times tables practice.
- PP children generally come to our Reception with lower baselines and lower speech and language skills than other children.
- Low self-esteem and low aspirations of some pupil premium children.
- Attendance and punctuality for some children is a barrier to learning and to well-being.

To update Tapestry online package to inform and enable parents of Reception children to be involved in their child's learning. £5000	The purchase of additional ICT resources for children to use in school as ICT facilities and broadband may not be readily available outside of school.	To update ICT hardware to ensure all children have access to reliable and up to date technology.	All children have the opportunity to use up-to-date, technology and resources to motivate, enrich and engage children across the curriculum.	7
£3500	To subsidise some transportation costs and the partial cost of trips and events.	To allow all children to access enrichment opportunities outside of the school environment.	All groups of children will have equal access to trips and events.	8
