Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

Our internal assessments data during 2023/24 showed that pupil premium pupils made the following progress from their starting points last year:

Reading – 86% of PP children made progress.

Writing – 87% of PP children made progress.

Maths – 87% of PP children made progress.

Early Years

- 55% of all children in the cohort achieved a GLD at the end of Reception.
- 43% of PP children (3 children) in this cohort achieved a GLD at the end of Reception.

Year 1

- 68% of children in the cohort achieved the expected standard in the phonics screening at the end of Y1.
- 54% of PP children (7 children) achieved the expected standard in the phonics screening at the end of Y1.

Year 2

- 80% of children in the cohort achieved the expected standard in reading at the end of Y2.
- 100% of PP children (3 children) in the cohort achieved the expected standard in reading at the end of Y2.
- 65% of children in the cohort achieved the expected standard in writing at the end of Y2.
- 67% of PP children (2 children) in the cohort achieved the expected standard in writing at the end of Y2.
- 70% of children in the cohort achieved the expected standard in maths at the end of Y2.
- 100% of PP children (3 children) in the cohort achieved the expected standard in maths at the end of Y2, including 33% (1 child) at greater depth.

Year 6

- 75% of children in the cohort taking the end of year tests (16) achieved the expected standard in reading at the end of Key Stage 2, including 12.5% at greater depth.
- 60% of PP children (3 children) in the cohort achieved the expected standard in reading at the end of Key Stage 2.

- 72% of children in the cohort achieved the expected standard in writing at the end of Key Stage 2, including 11% at greater depth.
- 50% of PP children (3 children) in the cohort achieved the expected standard in writing at the end of Key Stage 2.
- 87.5% of children in the cohort taking the end of year tests (16) achieved the expected standard in maths at the end of Key Stage 2, including 50% at greater depth.
- 40% of PP children (2 children) in the cohort achieved the expected standard in writing at the end of Key Stage 2, including 20% (1 child) at greater depth.
- 81.3% of children in the cohort taking the end of year tests (16) achieved the expected standard in grammar, punctuation and spelling at the end of Key Stage 2, including 50% at greater depth.
- 40% of PP children (2 children) in the cohort achieved the expected standard in grammar, punctuation and spelling at the end of Key Stage 2, including 20% (1 child) at greater depth.
- 62.5% of children in the cohort taking the end of year tests (16) achieved the expected standard in reading, writing and maths at the end of Key Stage 2.
- 40% of PP children (2 children) in the cohort achieved the expected standard in reading, writing and maths at the end of Key Stage 2.

Outcomes for PP children at the end of Key Stage 2 are primarily because of the additional needs of our PP cohort. 50% of the PP cohort had additional SEND needs. Of the Early Help or additional services with input being required, 80% were for PP children (4). Of the seven PP children, 57% (4) had either SEND or Early Help / other agency involvement and 14% (1) had both SEND and additional services involvement.

These children and families have benefited from our PP funding and all have made progress from their starting points.
